A BILL FOR AN ACT

101 **CONCERNING THE PROVISION OF SOCIAL WORKERS TO JUVENILES,**
102 **AND, IN CONNECTION THEREWITH, MAKING AND REDUCING**
103 **APPROPRIATIONS.**

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 21-1-104, **add** (4) as
3 follows:

4 **21-1-104. Duties of public defender.** (4) THE STATE PUBLIC
5 DEFENDER SHALL HIRE SOCIAL WORKERS, AS DEFINED IN SECTION
6 12-43-401 (11), C.R.S., TO ASSIST IN DEFENDING JUVENILE DEFENDANTS.

7 **SECTION 2. Appropriation - adjustments to 2014 long bill.**

8 (1) For the implementation of this act, the general fund appropriation
9 made in the annual general appropriation act to the controlled
10 maintenance trust fund created in section 24-75-302.5 (2) (a), Colorado
11 Revised Statutes, for the fiscal year beginning July 1, 2014, is decreased
12 by \$455,983.

13 (2) In addition to any other appropriation, there is hereby
14 appropriated, out of any moneys in the general fund, not otherwise
15 appropriated, to the judicial department, for the fiscal year beginning July
16 1, 2014, the sum of \$455,983 and 8.0 FTE, or so much thereof as may be
17 necessary, to be allocated to the office of the state public defender for the
18 implementation of this act as follows:

19 (a) \$410,759 and 8.0 FTE for personal services;

20 (b) \$7,600 for operating and travel expenses; and

21 (c) \$37,624 for capital outlay.

22 **SECTION 3. Safety clause.** The general assembly hereby finds,
23 determines, and declares that this act is necessary for the immediate
24 preservation of the public peace, health, and safety.
