 **ROOM 1E | EDUCATION ISSUES AND SCHOOL ENGAGEMENT**

We know "educational advocacy" is directly related to a holistic and complete representation, yet the black box of what "educational advocacy" means and how to do it effectively often leads attorneys to relegating it to a "collateral" status. School discipline records, placement, and special education can directly impact the way a prosecutor or judge perceives our clients and craft offers or sentences. This session aims to increase insight into how to effectively advocate for your client's educational rights, where to obtain resources that can help you, and who is available in the community to support you. Topics covered will include school safety plans, tips for effective school discipline and special education advocacy based on participant comments and questions, resources available to assist with effective educational advocacy, highlights of the legal framework of Title 22, and discussion of collateral consequences and considerations.

9:00AM - 10:15AM | PLENARY | THE INTERSECTION OF TRAUMA AND GANG ACTIVITY: FINDING THE MITIGATING NARRATIVE IN YOUTH GANG EXPERIENCE

In this session, participants will explore the impact of trauma in youth gang involvement, understanding how gang involvement is often the result of traumatic experiences rather than a predilection toward criminal activity. The trauma that both leads to and results from gang engagement must be examined, and courts at every level must seek education from anthropology, psychology, psychiatry and neuroscience to examine gang related cases effectively and equitably. Participants will explore narratives and specific recommendations for the investigation necessary to support this assertion in court, and learn what kind of treatment and resources best help youth disentangle themselves from gang activity.

 **ROOM 1F | GRASP AND COLORADO-SPECIFIC GANG RESOURCES**

GRASP [Gang Rescue and Support Project] is a peer-run, intervention program that works with youth who are at-risk of gang involvement or are presently active in gangs, helps families of gang victims, and serve as a youth advocates. Participants will learn about the process of introducing youth to new opportunities and how GRASP's counseling services support long-term transition off the streets.

 **ROOM 1E | EFFECTIVE PLACEMENT ADVOCACY**
Lydian Bowley, Sheri Danz, Mark Jensen, Diana Richett, and Lindsey Sandoual

This interactive session will cover legal arguments and practice tips for effective placement advocacy. Topics to be addressed include the adverse impact of detention on the health and well-being of youth, alternatives to detention, considerations when identifying appropriate and least restrictive placements, and strategies for bond modification. A brief overview and potential impact of the federal Family First Prevention Services Act and the expected Colorado Program Area 4 changes will be presented.

 **ROOM 1 A/B/C | BRIDGES: CONNECTING COLORADO'S CRIMINAL JUSTICE AND MENTAL HEALTH SYSTEMS**

Senate Bill 18-251, coined the "Bridges Program," was developed to connect Colorado's criminal justice and mental health systems. The legislation directs the placement of Court Liaisons across Colorado's 22 judicial districts. Court Liaisons will facilitate communication and collaboration between the two systems, supporting both juveniles and adults. Learn about the implementation of the program throughout Colorado, with its primary focus on "promoting positive outcomes for individuals living with mental health conditions and fostering collaboration so that all individuals are provided a fair chance of living a healthy and productive life."

ROOM ID | UNDERSTANDING TRANSGENDER & GENDER DIVERSE COMMUNITIES WITHIN THE COURT SYSTEM

In this workshop participants will develop understanding and empathy for the experiences and challenges faced by gender diverse and transgender people, including conditions of confinement; a working knowledge of the various ways people in the gender diverse and transgender community identify relating to gender identity and expression; an increased comfort level in communicating with, and using language related to, the gender diverse and transgender community; and an understanding of available community resources to support and act as an advocate to gender diverse and transgender people seeking services.

1:00PM -2:15PM | PLENARY | TRENDS IN MARIJUANA USE AMONG ADOLESCENT POPULATIONS AND THE EFFECT ON BRAIN AND PSYCHOLOGICAL DEVELOPMENT

This session will present the data for rates of marijuana use among youth populations and will explore long-term biopsychosocial effects of marijuana use. Brain development reaches a critical point during adolescence, and marijuana interferes with physiological processes that are essential for normative development. Disruptions in these processes can lead to difficulties in cognitive, social, and mental health functioning. These impairments significantly increase the likelihood that these youth will become justice involved.

Under the leadership of Governor Hickenlooper, Colorado partnered with the Council of State Governments [CSG] Justice Center and launched the Improving Outcomes for Youth [IOYouth] Initiative in May of 2018. Led by a bipartisan, interbranch, statewide taskforce, the CSG Justice Center conducted a data-driven assessment of the juvenile justice system, from the point a youth is referred to the system through a youth's reentry into the community. Through a PowerPoint presentation, this session will share key findings from CSG's assessment, with a focus on juvenile diversion, review best practices, and learn about the policies the state plans to adopt to align diversion policies, practices, and resources with what research shows works.
