The Colorado Juvenile Defender Center (CJDC) is honored to celebrate our 11th anniversary of youth justice advocacy! CJDC is Colorado's only nonprofit organization specifically dedicated to ensuring excellence in defense, advocacy, and justice for all children in Colorado.

CJDC strives to elevate the practice of defending children by holding up juvenile defense as a skilled specialty practice, presenting continuing legal education seminars, developing resources and materials for defenders and advocates, and by supporting indigent defense through ongoing litigation support and assistance.

CJDC seeks to protect the rights and improve the treatment of youth in contact with the criminal and juvenile justice systems through public advocacy, community organizing, non-partisan research, and policy development. Over the past decade, we have accomplished substantial youth justice reforms and helped build and foster a zealous juvenile defense bar in Colorado including:

- Removing children from adult jails;
- Ensuring that an attorney represents every detained child;
- Reducing the number of children prosecuted as adults;
- Eliminating juvenile life without parole;
- Establishing procedures that must be followed when children are isolated in custody;
- Creating oversight measures to monitor the use of solitary confinement by the (former) Colorado Division of Youth Corrections;
- Banning pretrial detention for 10-12-year-olds charged with nonviolent offenses;
- Streamlining the process for the children of Colorado to expunge their juvenile records.

In the past three years alone, CJDC has trained over 500 defense attorneys, social workers, investigators and advocates on issues ranging from direct file and transfer, to competency, immigration, education advocacy, expungement and de-registration, implicit racial bias, detention advocacy and beyond. CJDC also jointly published the 716-page 3rd Edition *Colorado Juvenile Defense Manual*®, and expanded our Believe in Youth project, formerly providing representation in expungement and de-registration, to also include expulsion and suspension proceedings.

It took a community to achieve these monumental results for Colorado youth and this work needs your support. Building on our success, CJDC has big plans to expand our direct representation services and advocacy on education proceedings in 2019. CJDC needs your financial support to make these initiatives a reality for the youth of Colorado.

Our 2019 Annual Fundraiser and Reception will be held in the Atrium of the Colorado Supreme Court from 5:00-7:00 pm on Thursday, April 25, 2019.
